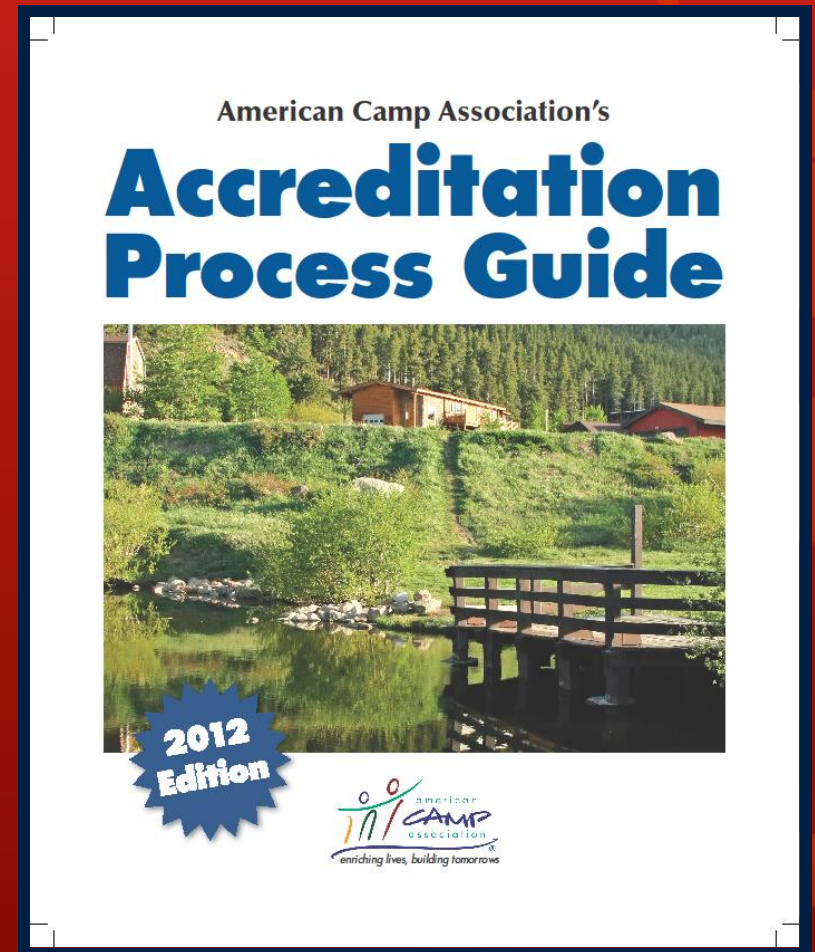


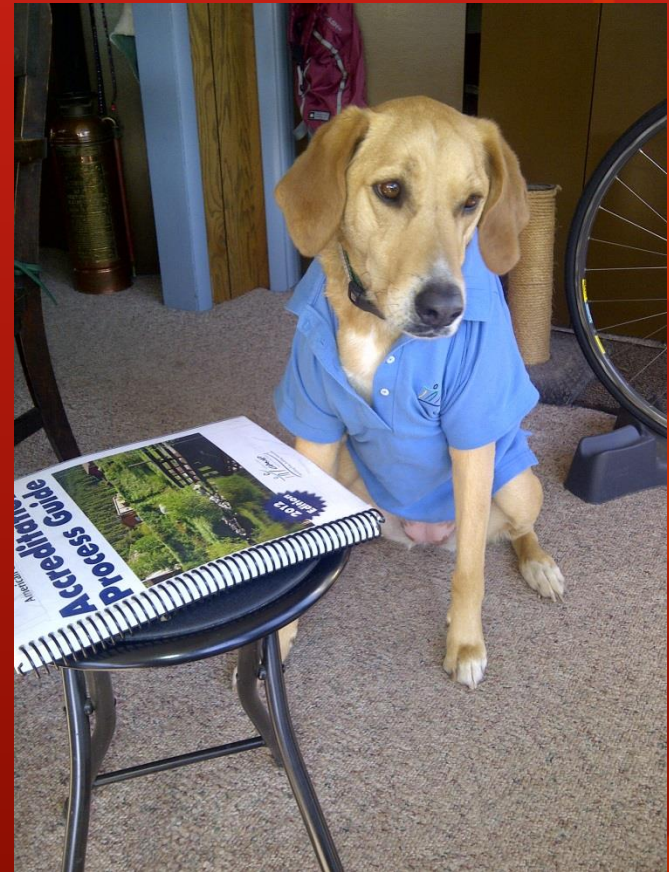

Most Missed Mandatory Standards

- Staff Health History Forms
 - Watercraft Rescue Skills Verification
 - Voluntary Disclosure Statements
 - National Sex Offender Public Website Checks
 - Swim Lifeguard Skills Verification

Most Missed Nonmandatory Standards

- Healthcare Provider - Resident Camps
 - Safety Apparel - Archery
 - Healthcare Policies Reviewed (at least every 3 yrs)
 - Availability of an AED
 - Electrical Evaluation

INTENTIONAL EXTENSIONS – up to 10% of camp scheduled for 2015 visit

- *Camp has been through the accreditation process at least three consecutive times successfully.*
- *There has been no change in the key leadership positions of the camp since the most recent visit (2012).*
- *The camp must remain current in camp fees and the Statement of Compliance must be signed prior to the start of the 2015 and 2016 camp seasons.*
- *No multi-site camps can be granted an extension.*
- *The camp agrees to the extension.*

Must also...

- Complete Standards Update
- Complete Pilot Annual Accreditation Report
- Complete report again in 2016

- **January 2012 Clarification/Revision to 2012 APG - Effective Summer 2012, Replacement pages** Ready to print back to back as "pull and replace" APG pages
