

**Clarification Scoring When Any Specialized Activities are Offered: Based on *the Accreditation Process Guide, 2012 Edition (9-2012)***

<b>Standard #/Title</b>	<b>Scoring Action/clarification</b>	<b>Notes</b>
<b>PD.8.5</b> Equipment inspection & maintenance records	Does not apply if no equipment for specialized activities is provided by the camp.	
<b>PD.12</b> Supervisor	Does not apply if the camp never provides staff for specialized activities	
<b>PD.13</b> Supervisor – Adventure/challenge	Do not apply if the camp never provides staff for adventure/challenge activities.	
<b>PD.14</b> Supervisor horse	Does not apply if the camp never provides staff for horseback riding activities.	
<b>PD.15</b> Staff skill verification	Does not apply if the camp never provides staff for specialized activities	
<b>PD.16</b> Supervision	Does not apply if the camp never provides staff for specialized activities	
<b>PD.17</b> First Aider	Does not apply if specialized activities are never offered by the camp or through staffed public facilities.	First Aider can be provided by either party
<b>PD.18</b> Safety Orientation	Does not apply if specialized activities are never offered by the camp or through staffed public facilities.	Can be provided by either party
<b>PD.19</b> Competency Demonstration	Does not apply if specialized activities are never offered by the camp or through staffed public facilities.	
<b>PD.20</b> Access to area	Does not apply if the camp does not provide specialized program activities on-site	
<b>PD.21</b> Spotters/belayers	Does not apply if the camp never provides activities that require spotting and only uses staffed public facilities.	
<b>PD.22</b> Supervision Rations	Does not apply if the camp never provides specialized program activities and only uses staffed public facilities.	
<b>PD.23</b> Safety/Emergency	Does not apply if specialized activities are never offered by the camp or through staffed public facilities	
<b>PD.24</b> Inspection of Challenge/Adventure Course	Does not apply if the camp does not have a ropes course, challenge course, climbing wall, rappelling tower, zip line, or other such constructed adventure/challenge area for which they are responsible.	
<b>PD.25</b> Archery Safety	Applies if program is offered by camp or SPF	
<b>PD.26</b> Rifle, etc. Safety	Applies if program is offered by camp or SPF	
<b>PD.27</b> Go-Kart Safety	Does not apply if go-karts are never provided by the camp or staffed public facilities	
<b>PD.28</b> ATV Safety	Does not apply if ATVs are never provided by the camp or staffed public facilities	
<b>PD.29</b> Protective Headgear	Does not apply if listed activities are never provided by the camp or by staffed public facilities.	
<b>PD.30</b> Protective Headgear – horses	Does not apply if horseback riding activities are never provided by the camp or by staffed public facilities	
<b>PD.31</b> Safety apparel	Does not apply if the related activities are never provided by the camp or by staffed public facilities.	
<b>PD.32</b> Horse Medication	Applies only if the camp provides horseback riding activities or uses livestock for program purposes	
<b>PD.33</b> Pony Rides	Applies only if camp provides pony rides	
<b>PD.34</b> Classifying Horses	Applies only if the camp provides the horses	
<b>PD.35</b> Horse Suitability	Applies only if the camp provides the horses	
<b>PD.36</b> Rider Classification	Applies only if the camp provides the horses
